Applications are invited from officers of Central Government to fill up vacancies in the grade of Scientist 'C' in Level -11 in the Pay Matrix in National Technical Research Organisation on deputation basis. Special Allowance @ 20% of Basic Pay will be admissible. No Deputation Duty Allowance will be paid.

2. The essential eligibility criteria for the aforementioned post are as under:-

(a) Officers of the Central Government

- (i). holding analogous post on regular basis in the parent cadre or department; **or**
- (ii). with three years of regular service in Level – 10 of the Pay Matrix; **and**

(b) Possessing the following essential educational qualifications and experience:-

- (i). First Class Master's Degree in Science in Physics or Electronics or Mathematics from a recognised University or Institute; **or**
First Class Bachelor's Degree in Engineering or Technology from a recognised University or Institute;
- (ii). Three years of Research or Design or Development or Technology Application or Operational Experience in Cyber Security/ Cyber Forensics/ Cyber Analysis/ Remote Sensing/ Geo Informatics System/ Geomatics;
- (iii). Knowledge of Computer Application

Note-1: The Departmental Officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment on promotion.

Note-2: The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed four years.

Note-3: The maximum age limit for appointment on deputation shall be not exceeding 56 years as on the closing date of the receipt of the application.
